UTC Time Date Conversion: Precision is key >> Lunar Node Date Time postings are all in UTC time, which is 8 hrs ahead of AU time, which is why stock momentum continues to rises 48 hrs after last day of Time-Gate Date. This means that the stock activity, because time is so precise, will behave accordingly. IMPORTANT NOTE: UTC TIME IS 8 hrs ahead. Therefore you get an extra day at the last time-gate date and the scan should begin the next day of calculated Time-Gate Date.

ARV Heart-Math using 1-yr previous graph done at dawn or 13:30LST or 21:00 LST @ 12 p.m. noon.

Calculating Time-Gate

You always calculate the future time-gate using the pre-calculated time-gate date from the past. Not the actual date shown on Astropixels, but the calculated date.

Recommendations:

WELL EFFECT >> Only trade before the well effect, not after

The Double Ingress Effect

** Double Ingress is mostly negative, although its effects last 24 hrs if Solar Weather is strongly green.

- ** Trading just before this period is most beneficial as sometimes it can elevate sws creating a 'well'. Check forecasted SWS speed.
- ** Mercury/Venus/Mars with Jupiter/Saturn/Uranus/Neptune/Pluto > Possible rise / volatility
- ** Gemini/Libra/Aquarius > less tech related
- ** Mars/Mercury ingress >> market drops
- ** Libra >> especially the Sun entering Libra around October >> drop

Works especially well when KP or solar weather variables are unstable. A stock that gets the most mentions over other stocks will usually perform stronger during Time-Gate week. This effect is strongest 1 day before the end of time-gate date

Geomagnetic Activity

Strongest effects are amplified first and last day of Time-Date Days, for better or worse You can check how severe the solar weather effects will be by checking if it is mentioned in Motley Fool Top Stocks to buy in ___Month___, Seeking Alpha News and Zacks Analyst Blog >> sometimes being mentioned up to 2 months before the start of the Time-Gate Date.

Momentum

May continue up to 48 hours after last day of Time-Gate as long as solar weather and everything else is in green zone

Calculation Protocol

1: >> Locate the Past Time-Gate (1-yr before) >> Example -- Thursday, 15 January 2004 to 21st January 2004 << calculate stocks during this time period for 1 week from 15th Jan 2004. **Present Time-Gate** >> Example - - 30 January 2005 to 5th Feb 2005.

2: Next ask >> "Show me a list of the strongest stocks that closed the highest at end of trading day from 15 January 2004 to 21st January 2004" >>

3: Next you find the Lunar Node for the week that is the next lunar node **AHEAD OF LAST YEARS**. This gives you the exact date for Time-Gate.

Overview

Everything has yearly re-emerging energy due to cycles. At 1 year this energy re-emerges and if there is negative solar weather present, it can disrupt the strongest stocks that showed the strongest energy 1-year ago from re-manifesting this surge of cyclic energy.

Heart-Math Time-Lock Protocol

PRIMING PROTOCOL

>> Must be done at LST peak time, preferably EXACTLY 24 hrs before day of ARV session.

>>> When priming 24 hrs before, after priming session, chips are stored with all other PSI chips. Priming involves steps 1 through 6 only.

1: TXP back of hand than placed at lower left ankle

2: Invoke Heart-Math of Appreciation

3: Freeze emotion around heart
